## 11. Toxicological information

Acute toxicity	: Not expected to be toxic. During use in engines, contamination of oil with low levels of cancer causing combustion products occurs. Used motor oils have been shown to cause skin cancer in mice following repeated application and continuous exposure. Brief or intermittent skin contact with used motor oil is not expected to have serious effects in humans if the oil is thoroughly removed by washing with soap and water. Avoid prolonged contact with motor oil.
- Inhalation	: Practically non toxic at normal conditions of usage. May cause respiratory irritation following prolonged or repeated inhalation of excessive oil mist and vapours.
- Dermal	: Not expected to be a primary skin irritant. Prolonged or repeated exposure may lead to dermatitis.
- Ocular	: Repeated exposure may cause a slight irritation.
- Ingestion	: Practically non toxic if swallowed in small doses. Larger quantities may cause nausea & diarrhoea.
